ENERGY STAR® List Changes for PY2024

As a reminder from the PY2024 CAA Kickoff, the Ameren Illinois Energy Efficiency Program will no longer accept specific measures (smart thermostat, exhaust fan, heat pump water heater, gas water heater and room air conditioner) that are not listed on the ENERGY STAR website.

There will be an exemption for submitting pre-purchased water heaters that were ENERGY STAR approved in PY2023. That will end on Friday, March 29, 2024, after which all incentivized water heaters will be required to be listed on the 2024 ENERGY STAR website.
