HOW TO APPLY

1 VERIFY ELIGIBILITY

- You must be a current Ameren Illinois electric or gas residential delivery service customer.
- Your primary heating source must be supplied by an Ameren Illinois delivered fuel, natural gas or electric.
- Smart thermostat must be ENERGY STAR certified. For a complete list of ENERGY STAR certified models, please visit: energystar.gov/productfinder/product/certified-connected-thermostats/results
- Working Wi-Fi connection.
- Review the program Terms and Conditions on Page 4.

2 INSTALL SMART THERMOSTAT

- Confirm your heating and cooling systems are compatible with the smart thermostat you have selected.
- Connect your new smart thermostat to the internet via a Wi-Fi connection and register with the manufacturer.

3 COMPLETE APPLICATION

- Application must be completed and signed by the customer with the Ameren Illinois account at the installation address. Please check your most recent Ameren Illinois bill to confirm who is listed as the account holder.
- Check your application to ensure it is correct, legible, complete and signed before submitting.
- If applying for two thermostats, complete the Smart Thermostat #2 section on Page 3.

Note: Each smart thermostat must be connected to a separate heating system supplied by an Ameren Illinois delivered fuel, natural gas or electric.

4 SUBMIT APPLICATION

- Include a legible copy of the entire sales receipt or contractor invoice, which includes:
 - Smart thermostat product information for each unit installed
 - Purchase price
 - Purchase date (and installation date if applicable)
 - Retailer or contractor business information
- Make a copy of the application and receipt or contractor invoice for your records.

5 RECEIVE REBATE PAYMENT

- After your rebate application is reviewed and approved, you will receive a rebate check in 4 to 6 weeks.

AMEREN ILLINOIS RESIDENTIAL ENERGY EFFICIENCY PROGRAM TERMS AND CONDITIONS

- 1. Definitions** – In addition to terms defined elsewhere herein, when any one of the following terms is used in these Terms and Conditions, wherein the first letter is written with a capital letter, then that term shall have the following definition. Words importing persons include corporation, and words importing only the singular include the plural and vice versa when the context requires.
- a) **“Ameren Illinois”** shall mean Ameren Illinois Company d/b/a Ameren Illinois.
 - b) **“Application”** shall mean the Customer completed document used to apply for cash incentives or used for any other appropriate application-specific documentation.
 - c) **“Customer”** shall mean an Eligible Customer who has submitted an Application for incentive money using their Ameren Illinois account number. The Customer abides by these Terms and Conditions upon acceptance of Customer’s Application by Ameren Illinois.
 - d) **“Eligible Customer”** shall mean a residential customer of Ameren Illinois, with an active Ameren Illinois-delivered electric or gas account residing in an existing home or new construction. Individually metered residential multifamily units must have prior program approval to participate. Installations performed between January 1, 2018 and December 31, 2018 are eligible for incentives or until incentive funds are exhausted. Equipment and/or materials must be installed at the Customer’s address listed on the Application. The Application must be filled out completely and accurately, signed and accompanied by dated copies of the invoices. See the project/measure eligibility for requirements specific to individual incentives.
 - e) **“Program”** shall mean the energy efficiency plan or measure that is the subject of the Application.
 - f) **“Program Manager”** shall mean the Ameren Illinois designee in charge of the Application.
- 2. General** – Customer shall abide by these Terms and Conditions; abide by all Local, State and Federal guidelines, applicable laws, building codes, regulations and licensing requirements; and perform work in accordance with customary installation standards, and/or according to manufacturer specifications.
- 3. Post-Installation Verification** – Ameren Illinois is not obligated to make any incentive payment unless it has performed a satisfactory post-installation verification. This provision may be waived at the sole discretion of Ameren Illinois. Inspections conducted are solely for the purpose of determining Program compliance and are not safety or building code inspections. Inspection may be requested up to one year from date of Application.
- 4. Indemnification** – Customer hereby releases and shall indemnify, hold harmless and defend Ameren Illinois, Program staff and authorized Ameren Representatives and any third party vendors from any and all claims, losses, harms, costs, liabilities, damages and expenses (including attorney’s fees) of any nature whatsoever arising directly or indirectly out of or in connection within any dispute or legal suit arising from work related to the Program.
- 5. Changes In/Cancellation of the Program** – a) Ameren Illinois may change the Program requirements and incentives or these Terms and Conditions at any time without notice, including suspending acceptance of Applications, denial of Applications already received, or terminating the Program. b) Cash incentives under the Ameren Illinois Program are offered on a first-come, first-served basis and are subject to project and Customer eligibility and the availability of funds.
- 6. Participation Release** – Customer authorizes the release of any smart thermostat usage data if applicable, including customer name and address, to Ameren Illinois, Program Manager, and any contractor or other vendor providing services or support under this Program.
- 7.** Ameren Illinois does not guarantee that certain energy savings will be achieved and does not make any warranties associated with the product eligible for incentives under this Program. Ameren Illinois has no obligations regarding, and does not endorse or guarantee, any claims, promises, representations, or work made or performed, or equipment furnished or installed by any contractors, subcontractors, or vendors that sell or install energy efficiency products.
- 8. Miscellaneous** – These Terms and Conditions shall be governed by Illinois law.
