Welcome and Thank You

- Welcome to the Team
 - You are important! Program Ally participation and engagement is vital to the success of the Ameren Illinois Energy Efficiency Program.
 - From Program Year 2023 through November 8, 2024, here is what YOU accomplished:
 - 394 Program Allies actively participated.
 - 6,940 projects were completed.
 - \$36.4 million in electric incentives have been paid.
 - \$5 million in gas incentives have been paid.
- Partnership
 - We need YOU! Our team is here to help you do what you do best: serve your customers.
 - We can answer your questions as well as provide clarification, one-on-one interaction and personalized Program guidance.

Program Ally Status

- Active Program Ally
 - Registered in the current Program year.
 - If initial registration occurs after September 30 of Program year, will maintain active status through following Program year.
 - Submitted and completed minimum of two projects.
 - Maintain certifications and submission of required documentation.
 - ICC certification is current.
 - Sign and submit Annual Program Ally Agreement.

- Why it matters the benefits for an Active Program Ally:
 - Eligible for Program Ally Bonus.
 - Up to 5% bonus of calculated incentive for eligible projects completed by deadline.
 - Eligible for Program Ally Marketing materials and assistance.
 - Free marketing material available for download.
 - Assistance creating your own unique marketing materials. Program approval is required.
 - Free listing on Program Ally search on website.
 - Be listed by service provided and service territory covered at AmerenIllinoisSavings.com/FindaContractor.

Available Business Project Bonuses

Early Completion Bonus

- 20% Completion Bonus—For ELECTRIC projects that have not received pre-approval prior to 9/30/24 and complete by 12/15/24
- 15%/10%/5% Completion Bonus—For eligible electric and gas projects that have not received preapproval prior to 11/14/24 and completed by: 3/31/25 for 15%, 6/30/25 for 10% and 9/30/25 for 5%

Program Ally Bonus

- Eligible PY2024 Projects must be completed and submitted by 11/30/24
- PY2025 Program Ally Bonus will remain 5% of approved incentive on eligible **ELECTRIC** projects. PA Bonus for eligible **GAS** projects will be 2% of approved incentive. Bonus deadline is 11/30/25.

Early Completion Bonus Terms

Early Completion Bonus

*This offer cannot be used in conjunction with any other special offers or bonuses. Only non-residential customer projects are eligible for this bonus. This bonus does not apply to the Online Store, Instant Incentives, Midstream HVAC/HPWH Offerings, Small Business Direct Install projects, Small Business Energy Performance projects, Staffing Grant, Strategic Energy Management (SEM), Metering & Monitoring, Feasibility Study, or Building Energy Assessment (BEA). Bonuses are capped at \$10,000 per project. Project and paperwork must adhere to all Ameren Illinois Energy Efficiency Program guidelines and requirements. This Bonus is based on Program funding and may be suspended at any time. Projects must be completed on or after January 1, 2025. Projects that had financial commitment or were pre-approved prior to November 14, 2024 are not eligible for the incentive bonus.

Program Ally Bonus Terms

Program Ally Bonus

*This offer cannot be used in conjunction with any other special offers or bonuses. Only non-residential customer projects are eligible for this bonus. This bonus does not apply to the Online Store, Midstream HVAC/HPWH Offerings, Small Business Direct Install projects, Small Business Energy Performance projects, Staffing Grant, Strategic Energy Management (SEM), Metering & Monitoring, Feasibility Study or Building Energy Assessment (BEA). Bonuses are capped at \$10,000 per project. Project and paperwork must adhere to all Ameren Illinois Energy Efficiency Program guidelines and requirements. This Bonus is based on Program funding and may be suspended at any time. Program Ally must be registered and in good standing to receive the Ally Bonus. For lighting projects, the Program Ally must submit projects through Amplify Online Lighting for Standard Lighting Projects, Streetlighting and New Construction Lighting projects. The Program Ally Bonus will apply to all electric and gas incentives. Projects must be completed on or after January 1, 2025. Projects that had financial commitment or were pre-approved prior to November 14, 2024 are not eligible for the incentive bonus. Minimum total bonus amount paid out will be \$50.

Annual Program Ally Agreement

- Review and agreement of the Standards outlined during your initial registration with the Program, along with updated Terms and Conditions.
 - This process document is being updated and will be sent out soon, but it MUST be returned by December 31, 2024.
 - This is required to maintain Active Program Ally status.

ICC Installer Certification

ICC Certification/Recertification

- Illinois energy legislation requires contractors who are installing energy efficiency measures to be certified with the Illinois Commerce Commission (ICC).
- Applies to any measure that requires a Class 1 electrical connection.
 AND
 Applies to any measure that will receive an incentive of \$300 or more.
- Certified installers agree to comply with building and electrical codes and manufacturer's installation instructions.
- Self-installed measures (those installed by an internal employee or staff member) are excluded from the certification requirement.

Recertification Details

- Certified energy efficiency measure installers must submit a recertification report.
- Installer Recertification must be submitted to the ICC between
 January 1 June 1 annually to avoid ICC late fees.
- There are no fees to recertify. However, late fees could be high if your recertification isn't submitted by June 1.
- Per Illinois State legislation, our Program cannot issue incentive payments until recertification is up to date.



Co-branding Requirements, Requests, Online Store, & Logos

Program Ally Marketing Portal

- A variety of marketing materials to help you sell energyefficient equipment and projects.
- Order a selection of professionally printed and downloadable pre-designed materials at <u>no charge</u> from the **Program Ally Marketing Portal** found on the Program Ally Portal.
- Access to this portal is managed by Program Ally "status."
 - Must have completed a project in the past two years to remain "Active" and keep access to the Program Ally Marketing Portal.

Co-Branding

- Co-branding refers to your company logo or name appearing with the Ameren Illinois logo/name on certain promotional materials.
- Co-branding is a way to market your business using your Ameren Illinois Energy Efficiency Program affiliation.
- Two types of co-branding materials:
 - FREE pre-designed materials on the Program Ally Marketing Portal.
 - We make materials for you to print and distribute.
 - No additional approval needed.
 - Materials using Program graphics.
 - You create your own materials and use our approved graphic.
 - Requires pre-approval from the Program.

Co-Branding Requirements

- All co-branding activity must adhere to the Co-Branding Requirements document found on the Program Ally Portal.
 - Approved graphic
 - Approve usage
 - Text references

Program Graphics

- Program graphics available for your advertising (websites, TV and radio ads, print ads, signage, etc.).
- In order to use Program graphics, you must be a Registered Program Ally.
- The Co-Branding Requirements document provides detailed standards and requirements and can be found on the Program Ally Portal.
- Your materials must adhere to the Co-Branding Requirements document and be approved in advance.

Quality Assurance and Control

- A goal of QA/QC is to maintain the quality and integrity of the Energy Efficiency Program.
 - We do this through on-site and virtual inspections, and customer satisfaction feedback.
- Inspections are vital to the quality and integrity of the program.
 - Projects may be inspected pre-installation and/or post-installation.
 - OProjects flagged for various reasons:
 - Random selection
 - Project metrics
 - Program Ally metrics
- Contact your Energy Advisor for project-specific inspection followup.

Program Ally Outreach and Engagement

- New in 2025: more engagement with Program Allies.
 - O Not just project-specific communications!
- Develop an atmosphere of teamwork and partnership.
 - We want to hear from you on how the program works, what is working well and suggestions for improvement.

*For paperwork requiring wet signatures, we will accept Docusign-type signatures – ID, date and timestamp certificates are required.

Small Business Direct Install (SBDI)

SBDI Channel Description:

- Only Ameren Illinois electric DS-2 & DS3-A (unless otherwise approved) customers are eligible. This includes commercial businesses, non-profits and private schools.
 - NEW! Public K-12 Schools with DS3-B accounts are now eligible!
 - Note: Current incentives rates have been extended through Q1 PY2025.
- Customers with Retail Electric Suppliers (RES) are eligible to participate with Ameren Illinois delivery service and their 10-digit electric account number.
 - Examples: Mid-American Energy, Homefield Energy and Constellation Energy
 - Customer must be interested in doing the project because of the incentives offered.
 Any customer that pays into the Energy Efficiency Program is eligible (unless deemed otherwise through verification).
- The Small Business Program Ally and Small Business Energy Advisor play critical roles in the SBDI process.

Small Business Direct Install (SBDI)

Small Business Program Ally (SBPA) Roles and Responsibilities

- Perform free Energy Assessments.
- Provide estimated sales tax on all assessments and get signed W9 for 1099 requirement.
- Work with customer to identify any possible project issues prior to installation and inform customer of any additional costs.
- Collect applicable project paperwork and submit to Snapshot for approval and payment.
- Complete projects and serve Ameren Illinois customers.

SBDI Channel - Upcoming Important Dates:

- 11/25/2024: PY2025 Snapshot Server Opens for New Projects
 - PY25 projects cannot complete until after 01/01/2025.
- 12/10/2024: PY2025 Snapshot Server Informational Training.
- 12/13/2024: PY2024 Snapshot Server closes for new projects.
- 12/27/2024: PY2024 Final Paperwork submission is recommended.
- 12/31/2024: PY2024 Snapshot Server closes to all paperwork.
- 01/01/2025: Updated SBPA Forms for payment are due.
 - W-9 form, ACH form and Vendor Master Change Forms.

 - Removal of the Tier 2 option for Ducted Air Source Heat Pumps (less than 65 kBtu).
