2025 EQUIPMENT ELIGIBILITY:

Smart Thermostats

- » Eligible for Business and Residential gas and electric customers.
- » Must be listed on the Approve Product List (APL). The APL can be found on the Midstream HVAC Portal. To be listed, the thermostat must have the default enabled capability or the capability to automatically establish a schedule of temperature setpoints according to driving device inputs above and beyond basic time and temperature data of conventional programmable thermostats. To request an addition to the APL, send request to instantincentives@ameren.com.
- » Limit one per Residential account.

Note: Smart thermostats cannot be given to customers at no cost. A minimum cost of \$0.01 is required.

Ducted Air Source Heat Pumps (less than 65 kBtu)

- » Eligible for Business and Residential electric customers.
 - » Note: Commercial packaged units are only eligible for Business electric customers.
- » Must be 15.2 SEER2 (16 SEER) and 8.1 HSPF2 (9.5 HSPF) or greater as confirmed by AHRI.
 - » For commercial packaged units, must be 15.2 SEER2 (16 SEER) and 7.5 HSPF2 (9.0 HSPF) or greater as confirmed by AHRI.
- » Limit two per Residential account.

Ducted Air Source Heat Pumps (65-134.9 kBtu)

- » Eligible for Business electric customers.
- » Must be 13.8 IEER and 3.4 COP or greater as confirmed by AHRI.

Ground Source Heat Pumps

- » Eligible for Residential Electric customers
- » Must be Energy Star certified
- » Must be Multi-stage/Part Load Capable
- » Must have an ECM for blower fan motor
- » Closed Loop Water to Air
- » Limit two per Residential account

***Additional \$500 if GSHP is installed with a desuperheater**

Ductless Mini-Split Heat Pumps

- » Eligible for Business and Residential electric customers.
- » Must be 16 SEER2 (16 SEER) and 8.55 HSPF2 (9.5 HSPF) or greater as confirmed by AHRI.
- » Limit two per Residential account.

Energy Recovery Ventilators (ERVs)

- » Only eligible for Ameren Illinois Residential customers
- » The unit must be listed in the Home Ventilation Institute's (HVI)-Certified Ratings Listing.
- » Limit two per Residential account.

Heat Pump Water Heaters

- » Eligible for Business and Residential electric customers.
- » Must be ENERGY STAR® listed.

AX and BX Section Notched V-belt

- » Eligible for Business electric customers.
- » Must be notched belts with AX or BX cross section.
- » Must be suitable for replacement of smooth V-belts between motor and fan in non-residential HVAC RTU systems.

PTAC/PTHP Units

- » New Units must be AHRI certified.
- » Available for business customers.
- » PTAC Units must be 12.3 EER or greater as confirmed by AHRI for systems <11,000 Btu/h.
- » PTAC Units must be 10.8 EER or greater as confirmed by AHRI for systems ≥11,000 Btu/h.
- » PTHP Units must be 12.3 EER and 3.5 COP or greater as confirmed by AHRI for systems <11,000 Btu/h.
- » PTHP Units must be 10.8 EER and 3.3 COP or greater as confirmed by AHRI for systems ≥11,000 Btu/h.

For multifamily complexes, the equipment quantity limits are per housing unit.
